SUBJECT: Award Contract for Asphalt Rejuvenating Agent


RECOMMENDED ACTION: That the City Council award the contract for 5,000 gallons of asphalt rejuvenating agent to Western Oil & Spreading Inc., Lodi, CA.

BACKGROUND INFORMATION: The specifications for rejuvenating agent were approved by the City Council at its meeting on May 7, 1986 and three (3) bids were received.

Asphalt rejuvenating agent costs have decreased 8% since the last time the City requested bids, which was May 1985.
