RECOMMENDED ACTION: That the City Council award the bid for the above project to Case Construction, the low bidder, in the amount of \$22,425.50.


BACKGROUND INFORMATION: Plans and specifications for this project were approved by the City Council on May 16, 1984. Bids were opened on Wednesday, May 30, 1984, and the following 2 bids were received:

A tabulation of the bids has also been attached.

The Engineer's estimate was low because we failed to include the necessary funds for tie-in paving of approximately \$2300.

The low bidder has done numerous jobs for the City, and it is felt he should be awarded the bid.
