Following introduction of the matter by City Attorney Stein, Council, on motion of Council Member Reid, Hinchman second, adopted Ordinance No. 1326 - An Urgency Ordinance of the City of Lodi amending Chapter 15 of the Lodi Municipal Code, by adding a new section thereto relating to the prohibition of the sale of fireworks within the City of Lodi.

ORDINANCE NO. 1326

AN URGENCY ORDINANCE OF THE CITY OF LODI AMENDING CHAPTER 15 OF THE LODI MUNICIPAL CODE, BY ADDING A NEW SECTION THERETO RELATING TO THE PROHIBITION OF THE SALE OF FIREWORKS WITHIN THE CITY OF LODI

BE IT ORDAINED BY THE LODI CITY COUNCIL, as follows:

Section 1. Chapter 15 of the Lodi Municipal, entitled "Offenses - Miscellaneous", Article 1, is hereby amended to add a new section relating to the prohibition of the sale of fireworks, as an emergency ordinance, effective the date of this ordinance, as follows:

"Section \_\_\_\_\_. It shall be a misdemeanor for any person to sell and/or offer for sale, any firecrackers, firerockets, roman candles, chasers or other fireworks of any nature or kind, within the City."

Section 2. The foregoing Ordinance No. 1326 was introduced and adopted as an urgency Ordinance due to the need to avoid personal injuries and property damage due to the sale and/or discharge of fireworks within the City of Lodi. The present Lodi Municipal Code provides a prohibition for the discharge of fireworks, but does not prohibit the sale of same.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi.


