Council was apprised that during the 1982-83 fiscal year, the City used 2107 Gas Tax money to maintain the alleys within the City. At the time the audit was done on these Gas Tax funds, it was determined that the alleys had not been accepted as part of the City Street System and for that reason they could not be maintained with these Gas Tax Funds. By adopting a resolution determining that the City's alleys are part of the City Street System, the City will be able to use the Gas Tax Funds for alley maintenance during the 1983-84 fiscal year.



**RECOMMENDED ACTION:** That the City Council adopt a resolution determining that the City's 16 miles of 20-foot paved alleys are part of the City Street System.

**BACKGROUND INFORMATION:** During the 1982-83 fiscal year, the City used 2107 Gas Tax money to maintain the alleys within the City. At the time the audit was done on these Gas Tax funds, it was determined that the alleys had not been accepted as part of the City Street System. For that reason they could not be maintained with these Gas Tax funds.
