RECOMMENDED ACTION: That the City Council award the contract for the above project to C.C. Wood Co. in the amount of \$33,395.00.


BACKGROUND INFORMATION: This project is the rehabilitation of Main Street with an asphalt concrete overlay and pavement reinforcing fabric.
