

ADOPTING AN OPERATING BUDGET FOR THE SUPPORT
OF VARIOUS DEPARTMENTS OF THE CITY OF LODI
AND A UTILITY OUTLAY BUDGET FOR THE FISCAL YEAR
BEGINNING JULY 1, 1981 AND ENDING JUNE 30, 1982

The City Council of the City of Lodi does ordain as
follows:

Section 1. - There is hereby appropriated and allocated
from unexpended and unappropriated balances of funds in the

beginning July 1, 1981 and ending June 30, 1982, the following
