ADOPTION OF ORDINANCE NO. 1360 AMENDING CITY COUNCIL SALARIES

Ordinance No. 1360 entitled, "AN ORDINANCE OF THE LODI CITY COUNCIL AMENDING LODI MUNICIPAL CODE CHAPTER 2, CITY COUNCIL SALARIES (TITLE 2, CHAPTER 2.08) AS AUTHORIZED BY GOVERNMENT CODE SECTION 36516 (a) (2)" was introduced by the Lodi City Council at its Regular Meeting of July 3, 1985.

Pursuant to State statutes, this ordinance provides that each member of the Lodi City Council shall receive a salary of \$400.00 per month. Council amended the original ordinance presented at the July 3, 1985 meeting to set forth the effective date of the salary increase as April 15, 1986.

The amended ordinance, which is attached, has been approved as to form by the City Attorney.

ORDINANCE NO. 1360

AN ORDINANCE OF THE LODI CITY COUNCIL
AMENDING LODI MUNICIPAL CODE CHAPTER 2, CITY COUNCIL
SALARIES (TITLE 2, CHAPTER 2.08) AS AUTHORIZED BY GOVERNMENT
CODE SECTION 36516(a) (2)

BE IT ORDAINED BY THE LODI CITY COUNCIL.

SECTION 1. Chapter 2, Section 2-83 (Title 2, Chapter 2.08.020) of the Lodi Municipal Code is hereby amended to read as follows:

"Each member of the council of the city shall receive, as salary, the sum of four hundred dollars (\$400) per month, as prescribed in Government Code Section 36516 in cities over 35,000 up to and including 50,000 in population, which shall be effective April 15, 1986 and shall be payable from and after the operative date of this chapter at the same time and in the same manner as the salaries are paid to other officers and employees of the city."

SECTION 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

SECTION 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


