

BEFORE THE LOCAL AGENCY FORMATION COMMISSION OF SAN JOAQUIN COUNTY
RESOLUTION DISAPPROVING THE TOWNE REORGANIZATION NO. 2 (LAFC 23-81),
INCLUDING ANNEXATION TO THE CITY OF LODI AND DETACHMENT FROM THE
WOODBIDGE RURAL COUNTY FIRE PROTECTION DISTRICT, WOODBRIDGE
IRRIGATION DISTRICT AND WOODBRIDGE WATER USERS CONSERVATION DISTRICT

WHEREAS, the above entitled proposal was initiated by Resolution
of the City of Lodi, and on June 23, 1981, the Executive Officer
certified the application filed for processing in accordance with
the District Reorganization Act; and,

WHEREAS, the Commission held a public hearing on the proposed
reorganization on July 17, 1981, in the Board of Supervisors
Chambers, County Courthouse, pursuant to notice of hearing which
was published, posted and mailed in accordance with State law; and,

WHEREAS, at said hearing the Commission heard and received
evidence, both oral and documentary, submitted in favor of and in
opposition to the proposed annexation and all persons present were
given an opportunity to hear and be heard in respect to any matter
relating to said proposal;

NOW, THEREFORE, the Local Agency Formation Commission of San
Joaquin County DOES HEREBY RESOLVE, AND ORDER as follows:

Section 1. The proposed Towne Reorganization No. 2 is hereby
disapproved, without prejudice, and all further proceeding are to
be abandoned.

Section 2. The Executive Officer is hereby authorized and
directed to mail and file certified copies of this resolution as
required by Section 56272 of the Government Code.
