AGREEMENT FOR SAFETY SERVICES WITH
SAN JOAQUIN COUNTY SAFETY COUNCIL

THIS AGREEMENT, made and entered into this 5th day of
August, 1981, by and between the CITY OF LODI, a
Municipal Corporation, hereinafter designated "CITY", and the
SAN JOAQUIN COUNTY SAFETY COUNCIL, an Association, hereinafter
designated "COUNCIL."

W I T N E S S E T H:

WHEREAS, Council is a non-profit association devoted ex-
clusively to accident prevention through education; and

WHEREAS, Council operates in the general public interest
serving the community as a whole and serving no special interest;
and

WHEREAS, Council desires to perform its services for City;

NOW, THEREFORE, in consideration of the promises and of the
mutual covenants and conditions herein contained, it is under-
stood and agreed by and between the parties hereto as follows,
to-wit:

(1) Council agrees to use its facilities and special know-
ledge for and on behalf of City in educating the community in
accident prevention, and to adhere to its general operating
policies as adopted by its Board of Directors in August, 1956.

(2) In consideration of the above services, the City agrees
to pay and contribute to Council the sum of ONE THOUSAND DOLLARS
(\$1,000.00) toward salaries and supplies during the fiscal year
1981-82.

(3) By the 15th day of each month, Council shall provide City with a statement detailing the expenditures for the preceding month of money agreed to be paid by the City hereunder. City reserves the right to inspect the records of Council at all reasonable times.

(4) The term of this contract shall be for the fiscal year commencing July 1, 1981, and ending June 30, 1982.
