RECOMMENDED ACTION: That Council adopt Resolution No. 87-100 authorizing the San Joaquin County Registrar of Voters, on behalf of the San Joaquin County Board of Supervisors, to canvass the November 3, 1987 Special Election returns for the City of Lodi.

The Elections Code of the State of California provides that the canvass of a Special Municipal Election shall be made by the City Clerk. Council, by Resolution action, has requested consolidation with the County of San Joaquin for the November 3, 1987 election. Section 23306 of the State of California Elections Code provides that, in case of the consolidation of any election called by the legislative body of a city, the governing body of that city may authorize the Board of Supervisors to canvass the returns of the election.

It is therefore recommended that Council authorize the San Joaquin County Registrar of Voters, on behalf of the San Joaquin County Board of Supervisors, to canvass the returns of the election. The official canvass shall be completed by December 1, 1987.



RESOLUTION NO. 87-100

RESOLUTION AUTHORIZING THE SAN JOAQUIN COUNTY REGISTRAR OF VOTERS, ON BEHALF OF THE SAN JOAQUIN COUNTY BOARD OF SUPERVISORS, TO CANVASS THE NOVEMBER 3, 1987 SPECIAL ELECTION RETURNS FOR THE CITY OF LODI

WHEREAS, a special election will be held and conducted in the City of Lodi, California, on Tuesday, November 3, 1987 as directed by the Lodi City Council and as set forth in Resolution No. 87-81 adopted at the regular council meeting of July 1, 1987.

WHEREAS, the City Council desires the canvass of election to be made pursuant to State Statutes.

WHEREAS, the City Council has, pursuant to Resolution No. 87-82 adopted July 1, 1987, requested consolidation with the County of San Joaquin for the November 3, 1987 Special Election.

NOW, THEREFORE, the City Council of the City of Lodi does resolved, declare, determine and order as follows:

Section 1. That, pursuant to State of California Elections Code Section 23306, the San Joaquin County Registrar of Voters, on behalf of the San Joaquin County Board of Supervisors, is hereby authorized to conduct the canvass of the results of the November 3, 1987 Special Election.

Section 2. That the San Joaquin County Registrar of Voters, on behalf of the San Joaquin County Board of Supervisors, shall complete the canvass of the November 3, 1987 election by December 1, 1987.

Section 3. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.




