OR M-1, LIGHT INDUSTRIAL TO M-2, HEAVY INDUSTRIAL


THE CITY COUNCIL OF THE CITY OF LODI DOES ORDAIN AS FOLLOWS:

Section 1. - The Official District Map of the City of Lodi adopted by Section 17.06 et seq of the City Code of the City of Lodi is hereby amended by rezoning Assessor Parcel No. 049-070-11, 42, 43 and 56 from R-1, Single-Family Residential or M-1, Light Industrial to M-2, Heavy Industrial.


Section 2. - All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.
