ORDINANCE AMENDING SECTION 15-20 OF THE LODI CITY CODE
ENTITLED TRESPASS AND LOITERING - DEFINITIONS CORRECTING
THE TELEPHONE NUMBER OF THE LODI POLICE DEPARTMENT

The City Council of the City of Lodi does ordain as follows:

Section 1. Section 15-20 of the Lodi City Code entitled, "Trespass and Loitering - Definitions" is hereby amended to read in full as follows:

"For the purposes of this article, the following words and phrases shall have the meanings respectively ascribed to them by this section:

Posted property. Any property specified in section 15-21 which is posted in the manner provided in Section 15-22.

Sign. A board, placard or card not less than one square foot in area and upon which, in lettering not less than two inches in height, appear the words "Stopping, Standing or Parking Vehicles Prohibited by Law. Vehicles Will Be Removed at Owner's Expense. LPD Phone (209) 333-6727" as to stopping, standing or parking; or upon which appear the words "Trespassing-Loitering Forbidden by Law," and any time limit that may be specified thereon, as to trespassing-loitering.

Section 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.
