SUBJECT: General Revenue Sharing Public Hearing before recipient government

Regulations provide that each recipient government which expends Revenue Sharing Funds in any fiscal year ---, shall have at least one public hearing on the government's proposed uses for entitlement funds in relation to its entire budget. The budget hearing shall be conducted by the legislative body, or the appropriate committee thereof, prior to enactment of the budget.

All citizens of the recipient government shall have a reasonable opportunity to provide written and oral comments, and to ask questions concerning the entire budget and the relationship of entitlement funds to the entire budget.

The budget hearing shall be held at a date, place, and time that permits and encourages public attendance and participation by all citizens.

It is recommended that Council set for Public Hearing, on October 6, 1982, at 8:00 pm consideration of the General Revenue Sharing portion of the 1982-83 Capital Improvement Program.


NOTICE IS HEREBY GIVEN that on Wednesday, October 6,
