RIGHT-OF-WAY AGREEMENT

500 No. Cluff Avenue

THIS AGREEMENT entered into this _____ day of August, 1981, by and between L. D. TONN and ROBERT L. TONN, hereinafter called Grantor, and the CITY OF LODI, hereinafter called City.

W I T N E S S E T H :

- 1. Grantor agrees to grant to the City and the City agrees to accept an easement deed for a portion of that certain real property in the City of Lodi, County of San Joaquin, State of California, commonly known as 500 No. Cluff Avenue. The parcel being deeded is shown on the attached sketch.**
- 2. City agrees to pay Grantor the sum of \$780 for the easement being granted when this Agreement is approved by both parties.**
- 3. City agrees to pay all title, escrow and recording fees.**
- 4. Both parties agree that they have herein set forth the whole of their Agreement. The performance of this Agreement constitutes the entire consideration and shall relieve City of all further obligation or claims.**
- 5. This Agreement is binding on the heirs, executors, administrators, and assigns of the parties hereto.**
