SUBJECT: Century Boulevard - Through Street

**RECOMMENDED ACTION:** That the City Council adopt a resolution establishing Century Boulevard as a through street from the west City limit to Cherokee Lane, except at Ham Lane and Hutchins Street.

**BACKGROUND INFORMATION:** City Council adopted the Specific Plan for ultimate development of Century Boulevard between Lower Sacramento Road and Cherokee Lane by Ordinances No. 928 and No. 940 in 1970 and 1971, respectively. The ordinance adopted Century Boulevard as an arterial with a street width of 64 feet (curb to curb), 4 lanes. Establishing Century Boulevard as a through street would allow the Public Works Directors to designate locations for stop sign installation on minor streets intersecting the through street without further City Council approval.
