 SUBJECT: Award of Street Department Dump Truck

RECOMMENDATION: That the City Council award the bid for the dump truck with emulsion tank to Interstate International, Stockton, CA in the amount of \$37,077.69 which includes sales tax.

BACKGROUND INFORMATION: The specifications for this item were approved by the City Council on August 5, 1981. Bids were opened on Wednesday, August 26, 1981 and the following bids were received.

<u>BIDDER</u>	<u>LOCATION</u>	<u>AMOUNT OF BID</u>
Geweke Ford	Lodi	\$ 35,899.30
Interstate International	Stockton	\$ 37,077.69

The low bid submitted by Geweke Ford has an exception to the specifications as to the Allison Automatic Transmission. To receive the specified transmission there would be an additional cost of \$2,574.40 added to the bid for a total of \$38,473.70. This bid would then be \$1,396.01 higher than Interstate International's bid.

It is estimated that the dump truck will be delivered to the City in approximately 180 days.

There was \$41,400 budgeted for this item in the 1981-82 budget.
