Council adopted Resolution No. 87-123 approving the 410' "No Parking" zone on the north side of Turner Road, east of Lower Sacramento Road, and the 290' "No Parking" zone on the south side of Turner Road, east of the existing "No Parking" zone.

Council was apprised that currently, Turner Road from Lower Sacramento Road to the Southern Pacific Railroad tracks, is being improved to provide additional lanes. The "No Parking" zone is recommended to accommodate the new striping plans which was presented for Council's perusal.







AGENDA TITLE: Establish No Parking Zone on Turner Road East of Lower Sacramento Road (North) (at General Mills)

RECOMMENDED ACTION: That the City Council approve the 410' no parking zone on the north side of Turner Road, east of Lower Sacramento Road, and the 290' no parking zone on the south side of Turner Road, east of the existing no parking zone.

BACKGROUND INFORMATION: Currently, Turner Road from Lower Sacramento Road to the Southern Pacific Railroad tracks is being improved to provide additional lanes. The no parking zone is recommended to accommodate the new striping plan as shown in the attached exhibit.


