Notice thereof having been published according to law, an affidavit of which publication is on file in the office of the City Clerk, Mayor Reid called for the Public Hearing regarding the proposed Hotel Lodi Renovation Project.

HOTEL LODI  
RENOVATION PROJECT

The matter was introduced by Community Development Director James Schroeder.

The history of the project and a CDBG Program Chronology of Events regarding the project were presented for Council's perusal.

Mr. Schroeder presented a letter that had been received from Mr. Robert Stone, Program Manager, State of California Department of Housing and Community Development, which read as follows:

"I am writing in response to your inquiry about the status of our SUHRP loan commitment for the Hotel Lodi should the City of Lodi fail to provide the financial assistance to this project described in your SUHRP application.

In brief, our commitment does not hinge on the availability of the City funds. Should you be able to substitute private equity capital for these funds, and produce a project that is otherwise as approved last March, our commitment would still stand and the project could move forward.

The City's withdrawal of its financial participation would be extremely disappointing, especially in light of its previously stated support in the project's application, and at a convocation we attended which included city officials, businessmen and residents, on February 28, 1986, to encourage the State's approval. Even if the City's withdrawal did not render the Lodi Hotel project infeasible, the quality of the project otherwise potentially achievable may be decreased. This would be to the detriment of both the community and future residents after the Hotel's renovation.

- c) Ms. Shirley Kleim, 216 East Oak Street, Lodi, presented a petition signed by 72 people in support of the project.
- d) Mr. Terry Knutson, 29 North Allen Drive, Lodi, stated that he believes that if City CDBG funds are kept in the City, the City will retain its control.
- e) Mr. John L. Barkley, Attorney-at-Law, 404 West Pine Street, Lodi, representing the property owner John Graffigna, stated that Mr. Graffigna is committed to sell the property and Mr. Logue is committed to buy. They will go forward with or without the City.

Following additional discussion, on motion of Mayor Pro Tempore Olson, Pinkerton second, the Public Hearing was continued to the Regular Council Meeting of October 1, 1986.

# Boston's booming urban revival Faneuil Marketplace starts a trend

BOSTON (UPI) — The weekday crowd at Faneuil Hall Marketplace is a mix of businessmen taking a lunch break, tourists who combine sightseeing with shopping and lozans watching the antics of a street juggler.

Ever since the festive site reopened on Aug. 26, 1976, it has been a magnet for downtown Boston, key to the city's booming urban revival.

The market remains a trendsetter, the first of dozens of "recreational shopping" areas that have opened in cities all over America.

Rows of colorful pushcarts offer a rainbow array of belts and suspenders, T-shirts, buttons, rafts, flowers, handmade woolens, original art, jewelry, rafts and spices.

Those who arrive with full bellies find the waiting aromas of fresh baked breads and other food so much a temptation to resist.

But choices don't come easy, given the market's 23 restaurants and taverns and 39 food stalls pestered among 150 retail shops in the 6-acre site.

It is a far cry from the same setting in the 1960s. There was a wholesale market operating at the site then, but it was falling apart. Its regular visitors included winos, pests, and seawater in the basements. There was no nightlife in the area, then nicknamed "Ghost Town."

"This has been the glue for the rest of development in every major city where festival marketplaces have occurred. This was the catalyst, breaking the barrier to the 'downtowns of America,'" says James B. McLean Jr., vice president of The Rouse Co., the Maryland firm that developed Faneuil Hall Marketplace.

After pioneering regional enclosed shopping malls in the 1960s, Rouse turned its sights to a new concept for cities, beginning with Boston.

"There was an idea, a vision, but there was a lot of risk involved," McLean said. "We sat here for four or five years with no return on investment because we were pumping everything back into it."

"What you need for recreational shopping is a commitment by the developer, the city, the architect and the lender. Those four pieces make these urban festival marketplaces go." And go they have.

Ideas all across the country have built on their downtowns, with retail areas that tend to focus on water — a nearby lake, a river, or even the ocean, as is happening with a new Rouse retail development called Bayside that is scheduled to open next year in Miami.

Harborplace in Baltimore, South Street Seaport in New York, Tabor Center in Denver, Market East in Philadelphia, National Place in Washington, D.C., The Grand Avenue in Milwaukee, and Union Station in St. Louis are soon to be

joined by Pioneer Place in Portland, Ore., Jacksonville Landing Florida, and Westlake in Seattle.

In Chicago, officials have been working to breathe new life in the city's old Navy Pier, which reopened this year. The war house-laden wharf, built in 1916, being renovated with plans that call for shops, theaters, private concession stands, farmer markets and loft space for artists.

Currently, the pier offers historical tours, free art programs at flea markets to the public, May Harold Washington has scheduled meetings here during the World Conference of Mayors.

Portland, Maine, waterfront came back to life in the past five years, spurred by redevelopment of the city's historic Old Port section. Its quaint brick-and-cobblestone look has become a major tourist draw.

"In Southern Maine, we have some real prosperity, and people got interested in waterfronts, general and ours, in particular. They also had the financial wherewithal to express that interest," said Thomas Balleau, the city's director of transportation and waterfront facilities.

"I would say the area has become exceedingly popular in the summer for a number of reasons. Now we are seeing a trend toward year-round popularity. The restaurants have increased year-round trade, and shopping is the same."

"For a long time the area was used for some traditional port and maritime purposes. It mostly went unnoticed and unappreciated by ordinary citizens. Only in the last five years these other kinds of businesses have started springing up," Balleau said.

The economic impact of such projects can be staggering in terms of giving a city a new development focus and a need for new hotels and additional retail and commercial centers.

"Boston from 1980 to 1990 will see \$1 billion worth of new building and renovation each year. That's \$1 billion," McLean said. "It creates jobs, new tax revenue, cultural opportunities. If a city didn't consider this, they would be thinking in the past and treating their people as slaves."

"We're just at the tip of it. Officials must make strategic plans looking to where they want to take their cities over the next 10 to 20 years."

Faneuil Hall Marketplace, which draws an average of 15 million visitors per year, is celebrating its 10th anniversary this month with a series of free concerts, parade and author appearances. Best Pops performance, a laser light show and a gala ball.

# Ralph Trovingers honored at 65th anniversary buffet party


Ralph and Emma Trovinger observed their 65th wedding anniversary at a recent buffet party at their Acampo home.

Mr. Trovinger was an anthracite hard coal miner in Pennsylvania for more than 30 years and came to California in 1945. He was employed by Earl Fruit Company for 11 years.


I am writing in response to your inquiry about the status of our SUHRP loan commitment for the Hotel Lodi should the City of Lodi fail to provide the financial assistance to this project described in your SUHRP application.

In brief, our commitment does not hinge on the availability of the City funds. Should you be able to substitute private equity capital for these funds, and produce a project that is otherwise as approved last March, our commitment would still stand and the project could move forward.

The City's withdrawal of its financial participation would be extremely disappointing, especially in light of its previously stated support in the project's application, and at a convocation we attended which included city officials, businessmen and residents, on February 28, 1986, to encourage the State's approval. Even if the City's withdrawal did not render the Lodi Hotel project infeasible, the quality of the project otherwise potentially achievable may be decreased. This would be to the detriment of both the community and future residents after the Hotel's renovation.


