
RECOMMENDED ACTION: That the City Council award the bid for asphalt materials for the second and third quarters of fiscal year 1983-84 as follows:

BACKGROUND INFORMATION: The specifications for asphalt materials were approved by the City Council at its meeting September 7, 1983 and two (2) bids were received.

The cost of asphalt F.O.B. plant increased approximately one percent, the cost of asphalt delivered to the paver decreased approximately one percent since the last bid was requested in June 1983.
