
SUBJECT: PURCHASE OF 600-VOLT TRIPLEX XLPE CABLE (EUD-86-7)

On Tuesday, September 30, 1986, bids were received for 20,000 feet of #2 Aluminum, 20,000 feet of #1/0 Aluminum and 30,000 feet of 350 MCM Aluminum 600-volt Triplex cable.

The cable will be used throughout the city to serve developments currently being designed, as well as for services to homes and apartments, etc., under construction or in the planning state and to maintain an inventory for other needs as they develop. Some of the specific projects requiring this cable are:

Noma Ranch #2  
Park West #8  
Sun West #4, 5, 6 & 7  
Woodlake North II

Based on the bids received, it is recommended that the bid be awarded, in total, to the low bidder Pirelli Cable Corporation, Colusa, California in the amount of \$54,409.80. Funding is available in the Electric Department's operating fund for this purchase.
