Ordinance No. 1392 - An Ordinance of the City of Lodi rezoning Towne Ranch, a 78.3 acre residential subdivision, located on the south side of West Turner Road and west of Lower Sacramento Road to P-D, Planned Development District, to accommodate single and multiple-family residential uses was introduced following a Public Hearing on the matter held October 8, 1986.

ORDINANCE NO. 1392

AN ORDINANCE PREZONING TOWNE RANCH, A 78.3 ACRE
RESIDENTIAL SUBDIVISION, LOCATED ON THE SOUTH SIDE
OF WEST TURNER ROAD AND WEST OF LOWER SACRAMENTO
ROAD TO P-D, PLANNED DEVELOPMENT DISTRICT, TO
ACCOMMODATE SINGLE AND MIULTIPLE-FAMILY RESIDENTIAL USES

The City Council of the City of Lodi does ordain as follows:

Section 1. Towne Ranch, a 78.3 acre residential subdivision, located on the south side of West Turner Road and west of Lower Sacramento Road P-D, Planned Development District, is hereby prezoned to accommodate single and multiple family residential uses.

The alterations, changes, and amendments of said Official District Map of the City of Lodi herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearings held in conformance with provisions of Chapter 27 of the Code of the City of Lodi and the laws of the State of California applicable thereto.


Section 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


