ORDINANCE NO. 1339

ORDINANCE PREZONING THE MILLS PARCEL U-H,
UNCLASSIFIED HOLDING UNTIL A DEVELOPMENT PLAN
CAN BE APPROVED BY THE PLANNING COMMISSION AND
THE CITY COUNCIL

The City Council of the City of Lodi does ordain as follows:

Section 1. The property hereinafter described and known as the "Mills Parcel" shall be prezoned to U-H, Unclassified Holding until a development plan can be approved by the Planning Commission and the City Council. Assessor's Parcel No. 029-030-29, commonly known as 2401 West Lodi Avenue, Lodi, California.

The alterations, changes, and amendments of said Official District Map of the City of Lodi herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearings held in conformance with provisions of Chapter 27 of the Code of the City of Lodi and the laws of the State of California applicable thereto.

Section 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


