ORDINANCE NO. 1302

AN ORDINANCE OF THE CITY OF LODI AMENDING SECTION 1
OF ORDINANCE NO. 1167 DEALING WITH PARCEL MAP
REQUIREMENTS

The City Council of the City of Lodi does ordain as follows:

Section 1. "A parcel map shall be filed and recorded for any subdivision of four or fewer parcels or for any subdivision for which a tentative and final map is not required by the Subdivision Map Act or this ordinance.

"Such a parcel maps shall meet all the requirements of the Subdivision Map Act and of this ordinance and shall show all dedications or offers of dedication thereon.

"The City Clerk of the City of Lodi or the City Engineer/Ex Officio City Clerk of the City of Lodi may accept or reject dedications and offers of dedications for streets and easements that are made on such map."

Section 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel", a daily newspaper of general circulation, printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.
