RECOMMENDED ACTION: That the City Council eliminate the 12-minute parking zone as shown on the attached sketch.

BACKGROUND INFORMATION: In November 1977, the City Council established a 12-minute zone in front of the Pacific Telephone Business Office on West Elm Street to eliminate a double parking and jaywalking problem in the area caused by people paying their phone bills.

Since the building is no longer being used for that purpose the Public Works Department recommends the zone be eliminated.
