**BACKGROUND INFORMATION:** The specifications for "Lane Line Painting" were approved by the City Council on November 7, 1984. Bids were opened on Wednesday, November 21, 1984 and three bids were received. The cost of painting a mile of lane lines is approximately the same as the 1983 bid.


