RECOMMENDED ACTION: That the City Council award the bid for the Tractor Loader to Case Power & Equipment in the amount of \$16,465.00, which includes trade-in and sales tax.

BACKGROUND INFORMATION: The specifications for this item were approved by the City Council on November 17, 1982. Bids were opened on Tuesday, November 23, 1982 and the following 4 bids were received.
