BACKGROUND INFORMATION: At its regular meeting of August 6, 1986 the City Council took action approving compensation adjustments for the three positions in the City organization which are City Council appointees, namely, City Manager, City Attorney and City Clerk. The action taken at that time narrowed the difference between the then existing compensation rate and the "control point" determined by a salary survey. Earlier action by the City Council established salary ranges for department heads which moved these positions to the "control point". At the request of Mayor Reid, this item has been placed on this agenda. City Council adoption of the attached resolution (Exhibit A) will bring these three positions to the "control point".
