ORDINANCE NO. 333

AN ORDINANCE ESTABLISHING THE OFFICE OF SUPERINTENDENT OF  
STREETS AND PARKS AND DEFINING THE POWERS AND DUTIES OF  
SUCH OFFICE.

The City Council of the City of Lodi does ordain as follows:

Section 1. The office of Superintendent of Streets and Parks is hereby established.

Section 2. The person appointed to be such Superintendent shall do and perform all the duties of Superintendent of Streets as may be prescribed by common usage, by law and by ordinance, particularly, but not limited to, the duties prescribed in Article 1 of Chapter 25 of the Streets and Highways Code of this State.

In addition to the above, as Superintendent of Parks, he shall supervise the maintenance and care of all parks belonging to or operated by the City, including Lodi Lake Park, Hale Park, Lawrence Park, Lodi Stadium, the old Salem School Grounds and any and all other public parks and grounds hereafter acquired by the City. He shall maintain and care for the yards around and adjacent to all public buildings owned or operated by the City and shall have supervision over all employees engaged in the care and maintenance of such parks and yards.

In accordance with Section 5682 of the ~~Street and~~ Highways Code, he shall post a bond in the penal amount of \$ 1,000.00, conditioned as in said section, and, before entering upon his duties, he shall make and subscribe to the statutory oath of office.


The salary of said Superintendent of ~~Streets and~~ Parks shall be that determined from time to time by this City Council by order entered in its minutes. He shall serve in this office at the pleasure of the City Council, subject however to the provisions of Subsection (b) of Section 5 of Ordinance No. 276 of this City.

Section 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed in so far as such conflict may exist.


