ORDINANCE NO. 377

AMENDING SUBDIVISION (6) OF SECTION 1 OF  
ORDINANCE NO. 365 ADOPTED MARCH 3, 1948  
FOR THE PURPOSE OF REZONING EACH OF LOTS  
37, 38 AND 39 OF WALNUT ORCHARD TRACT.

The City Council of the City of Lodi does ordain as follows:

Section 1. Subdivision (6) of Section 1 of Ordinance No. 365 entitled,  
"AN ORDINANCE AMENDING THE ZONE DISTRICT MAP OF THE CITY OF LODI BY ADDING  
THERE TO WOODLAKE TRACT, SPERRY ADDITION, KRIEGER ADDITION, TURNAGE ADDI-  
TION, BALLENTYNE ADDITION, WALNUT ORCHARD ADDITION, MEMORIAL HOSPITAL  
ADDITION, MORENZ ADDITION AND LAKE STREET ADDITION, CLASSIFYING AND  
ZONING PROPERTIES THEREIN AND ALSO ZONING RUMINSON TRACT (LOT 52 OF  
LODI BARNHART TRACT), is hereby amended to read as follows:

(6) WALNUT ORCHARD ADDITION, annexation effective July 17, 1947.

Each of Lots One (1) to Thirty-six (36) both inclusive, as the same are  
displayed on the official map of "Walnut Orchard Tract" and a parcel of  
land bounded Southerly by the  $\frac{1}{4}$   $\frac{1}{4}$  section line, Easterly by Lloyd Street,  
Northerly by the South line of Lot 40 and Westerly by the east line of  
Lot 41 in said Walnut Orchard Tract, shall be reclassified and rezoned  
to be in the ONE AND TWO FAMILY RESIDENCE DISTRICT ZONE.

Each of Lots Thirty-seven (37), Thirty-eight (38) and Thirty-  
nine (39) shall be reclassified and rezoned to be in the MULTIPLE FAMILY  
RESIDENCE DISTRICT ZONE.

Each of Lots Forty-one (41), Forty-two (42), and Forty-three  
(43) of said Tract and the parcel of land lying North of the north lines

of Lots 43 and 38 and West of the west line of Lot 37 of said Walnut Orchard Tract, bounded Westerly by State Highway 4 and Northerly by the south line of "Xrieger Addition", shall be reclassified and rezoned to be in the **COMMERCIAL DISTRICT ZONE.**

This ordinance is passed and adopted in accordance with the provisions of the Zoning Law of 1917 (Act 994, Bering General Laws) and Section 13 of Ordinance No. 238 (Zoning Ordinance) of the City of Lodi and after public hearings had before the City Planning Commission and the City Council of the City of Lodi.


Section 2. This ordinance shall be published one time in THE MM TIMES and shall be in force and take effect at the time and in the manner provided by law,
