ORDINANCE NO. 425

AMENDING THE ZONE DISTRICT MAP OF THE
CITY OF LODI AND THEREBY REZONING LOTS
5, 6 AND 7 IN BLOCK 33 AND LOTS 2, 3
AND 4 IN BLOCK 34, MAP OF MOKELUMNE TO
BE IN THE COMMERCIAL DISTRICT ZONE.

The City Council of the City of Lodi does ordain as follows:

Section 1. The Zone District Map of the City of Lodi, adopted by Section 2 of Ordinance No. 238, (Zoning Ordinance), as amended, is hereby further amended and the properties hereinafter described reclassified and rezoned from their present classification as being in the Multiple Family Residential District Zone to be in the COMMERCIAL DISTRICT ZONE, Viz:

EACH OF LOTS FIVE (5), SIX (6) AND SEVEN (7) IN BLOCK THIRTY-THREE (33) AND EACH OF LOTS TWO (2), THREE (3) AND FOUR (4) IN BLOCK THIRTY-FOUR (34), MAP OF MOKELUMNE, NOW CITY OF LODI, FILED AUGUST 25, 1869 IN VOL. 2 OF MAPS, PAGE 12, RECORDS OF SAN JOAQUIN COUNTY.

The alterations, changes and amendments to said " Zone District Map " herein set forth have been approved by the City Planning Commission and by the City Council of *this* City after public hearings held in conformance with the provisions of Ordinance No. 238 of the City of Lodi and the laws of the State of California applicable hereto.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed in so far as such conflict may exist.




