ORDINANCE NO. 435

AMENDING THE ZONE DISTRICT MAP OF THE CITY  
OF LODI BY ADDING THERETO LAKESIDE PARK  
ADDITION AND ZONING AND CLASSIFYING THE  
LOTS THEREIN

The City Council of the City of Lodi does ordain as follows :

Section 1. The Zone District Map of the City of Lodi adapted by  
Section 2 of Ordinance No. 238, as amended, shall be further amended  
by adding thereto LAKESIDE PARK ADDITION annexed to the City of Lodi  
on July 26, 1950 and the lots comprising said addition shall be class-  
ified and zoned in the manner and to the extent herein set forth, viz:

LOTS 1, 2, AND 3 AND LOTS 26 to 32, BOTH INCLUSIVE, AS SAID  
LOTS ARE SO DESIGNATED ON THE OFFICIAL MAP OF LAKESIDE PARK  
ON FILE AND OF RECORD IN THE OFFICE OF THE COUNTY RECORDER  
OF SAN JOAQUIN COUNTY, CALIFORNIA, SHALL BE CLASSIFIED AND  
ZONED TO BE IN THE COMMERCIAL DISTRICT ZONE. EACH AND ALL  
OF THE REMAINING LOTS IN THIS SUBDIVISION SHALL BE CLASSIFIED  
TO BE IN THE ONE AND TWO FAMILY RESIDENCE DISTRICT ZONE AS  
SAID ZONES ARE DEFINED BY THE PROVISIONS OF SAID ORDINANCE NO.  
238 OF THE CITY OF LODI, COMMONLY CALLED " THE ZONING ORDINANCE

Section 2. This ordinance shall be published one time in The Lod  
Times, a weekly newspaper published in the City of Lodi and shall be  
in force and take effect thirty days from its passage.


