ORDINANCE NO. 455

AMENDING THE ZONE DISTRICT MAP OF THE CITY OF LODI AND THEREBY REZONING AND RECLASSIFYING EACH OF LOTS 18, 20, 22 AND 24, BLOCK B, SUBDIVISION OF LOT 72, LODI BARNHART TRACT, TO BE IN THE INDUSTRIAL DISTRICT ZONE

The City Council of the City of Lodi does ordain as follows:

Section 1. The Zone District Map of the City of Lodi adopted by Section 2 of Ordinance No. 238 as amended is hereby further amended by altering the zone boundary lines displayed on said amended map to the following effect:

THAT EACH OF LOTS NUMBERED 18, 20, 22 AND 24 IN BLOCK B, SUBDIVISION OF LOT 72, LODI BARNHART TRACT, BE REZONED AND RECLASSIFIED FROM THEIR PRESENT CLASSIFICATION TO BE, FROM AND AFTER THE EFFECTIVE DATE OF THIS ORDINANCE, IN THE INDUSTRIAL DISTRICT ZONE.

The amendment made herein to said Zone District Map is made after public hearings had before the City Planning Commission and the City Council of the City of Lodi in accordance with the provisions of Ordinance No. 238 (Zoning Ordinance) and in accordance with State laws applicable hereto.


Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed in so far as such conflict may exist.

Section 3. This ordinance shall be published one time in The Lodi Times, a newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


