ORDINANCE NO. 514

AN ORDINANCE OF THE CITY OF LODI AMENDING ORDINANCE NUMBER 493, ENTITLED "AN ORDINANCE OF THE CITY OF LODI REGULATING TRAFFIC UPON THE PUBLIC STREETS AND REPEALING ORDINANCES NUMBERS 64, 137, 222, 233, 446 AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH"

The City Council of the City of Lodi does ordain as follows :

Section 1. Ordinance No. 493 of the City of Lodi is hereby amended by the addition of a new section which shall read as follows:

.Section 72. RESTRICTED TURNING MOVEMENTS Whenever any ordinance or resolution of this city designates any intersection at which drivers of vehicles shall not make a right, left, or U turn, the City Engineer shall place and maintain signs giving notice thereof, and no such regulations shall be effective unless such signs are in place.

Section 2. Section 161 of Ordinance No. 493 of the City of Lodi is hereby repealed and the following is hereby substituted therefor:

Section 161. COMMERCIAL VEHICLES AND TRUCKS PROHIBITED FROM USING CERTAIN STREETS. (a) Whenever any ordinance of this city designates and describes any street or portion thereof as a street the use of which is prohibited by any commercial vehicle or by any vehicle exceeding a maximum gross weight limit of three (3) tons, the City Engineer shall erect and maintain appropriate signs on those streets affected by such ordinance.

(b) Those streets and parts of streets described in Section 198 hereof are hereby declared to be streets the use of which is prohibited by any commercial vehicle or by any vehicle exceeding a maximum gross weight limit of three (3) tons. The provisions of this section shall not apply to passenger buses under the jurisdiction of the Public Utilities Commission or operating under franchise with the City of Lodi.

Section 3. Section 192 of Ordinance No. 493 of the City of Lodi is hereby amended by the addition of paragraph (e) which shall read as follows:

(e) Holly Drive at Ham Lane.

Section 4. Section 198 of Ordinance No. 493 of the City of Lodi is hereby repealed and the following is hereby substituted therefor:

Section 198. COMMERCIAL VEHICLES AND TRUCKS PROHIBITED. In accordance with Section 161, the following streets and parts of streets are hereby declared to be streets the use of which is prohibited by any commercial vehicle or by any vehicle exceeding a maximum gross weight limit of three (3) tons, as prescribed below:

(a) Vehicles exceeding a maximum gross weight limit of three (3) tons:


(1) Holly Drive.

Section 5. The City Clerk shall certify to the passage of this ordinance and cause the same to be published one time in the "Lodi News-Sentinel", a daily newspaper of general

circulation printed and published in the City of Lodi and shall be in force and take effect ~~thirty~~ days from and after its passage.
