ORDINANCE NO. 526

AMENDING THE OFFICIAL DISTRICT MAP OF
THE CITY OF LODI AND THEREBY REZONING
CERTAIN PROPERTY IN THE SOUTHEAST QUAR-
TER OF SECTION THIRTY-SIX, TOWNSHIP 4
NORTH, RANGE 6 EAST, M.D.B. & M. TO BE
IN THE R-4 DISTRICT

The City Council of the City of Lodi does ordain as follows :

Section 1. The Official District Map of the City of Lodi, adopted by Section 2 of Ordinance No. 469 (Zoning Ordinance) is hereby amended and the property hereinafter described reclassified and rezoned from its present classification as being in the R-1 Residence District to be in the R-4 Residence District, viz:

Commencing at a point on the South line of Section 36, T4N, R6E, M.D.B. & M., 444 feet East of the Southwest corner of said Section 36; thence North 987 feet to the left bank of the Mokelumne River and run thence upstream North 50° 30' East 158 feet; thence South 1° 30' East along fence 1088 feet to the South line of Section 36; thence West to beginning.

The alterations, changes and amendments of said "Official District Map of the City of Lodi" herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearing held in conformance with the provisions of Ordinance No. 469 of the City of Lodi and the laws of the State of California applicable hereto.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed in so far as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News-Sentinel" and shall be in full force and take effect thirty (30) days from and after its passage and approval.
