ORDINANCE NO. 590

APPROVING THE ANNEXATION OF THE BLAZER
ADDITION TO THE CITY OF LODI AND DECLAR-
ING THAT THE SAME IS ANNEXED TO AND MADE
PART OF THE CITY OF LODI

WHEREAS, the Boundary Commission of San Joaquin County did, on the 4th day of March, 1957, approve the boundary line description of the hereinafter described territory, proposed for annexation to the City of Lodi, as to definiteness and certainty, and

WHEREAS, on the 3rd day of April, 1957, the City Council of the City of Lodi did initiate proceedings and declare its intention to annex to said City the hereinafter described uninhabited territory, thereupon Resolution No. 2015, giving notice of the proposed annexation and of the time and place for the hearing of protests against such annexation, was adopted by said City Council, such hearing to be held in the City Council Chambers, City Hall, Lodi, California, beginning at 8:00 o'clock p.m. of Wednesday, May 15, 1957, and

WHEREAS, subsequent to the adoption of said Resolution No. 2015, conforming therewith and with the provisions of the "Annexation of Uninhabited Territory Act of 1939", notice was given owners of property within the territory proposed for annexation by publication of said Resolution No. 2015 in newspapers of general circulation printed and published in the City of Lodi and in San Joaquin County outside said City as is evidenced by affidavits thereof on file and of record in the office of the City Clerk of the

City of Lodi, said publications being completed more than twenty days prior to the date of hearing set in Resolution No. 2015, and

WHEREAS, on the 15th day of May, 1957, at the hour of 8:00 o'clock p.m. of said day, in the City Council Chambers, City Hall, Lodi, California, pursuant to resolution and notice aforesaid, the City Council of the City of Lodi did hold and conduct a public hearing for the hearing of protests or objections against the annexation of said territory to the City of Lodi, and said protests being heard, considered and passed upon by said City Council, and found to have been made by owners of less than one-half of the assessed value of the territory proposed to be annexed as shown by the last equalized assessment roll of San Joaquin County, California, now therefore

THE CITY COUNCIL OF THE CITY OF LODI DOES ORDAIN AS FOLLOWS:

Section 1. The annexation of the following described uninhabited territory in San Joaquin County, contiguous to the City of Lodi, designated "Blazer Addition" is hereby approved and the same is hereby declared to be annexed to and made part of the City of Lodi:

A portion of the Southeast Quarter of Section 3, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, San Joaquin County, California and more particularly described as follows:

Commencing at the point of intersection between the East line of said Southeast Quarter and the North line of Sargent Road, which point lies 30 feet, more or less, northerly from the Southeast


corner of said Southeast Quarter, which point further lies on the present boundary line of the City of Lodi; thence Westerly along said North line and City boundary line 110 feet; thence Northerly and parallel to said East line 198 feet; thence Easterly and parallel to the south line of said Southeast Quarter 110 feet, more or less, to said East line; thence South along said East line 198 feet, more or less to the point of beginning containing 0.5 acres, more or less.

Reference is hereby made to a map or plat on file in the office of the City Clerk of this City delineating the boundaries next above described.


Section 2. This ordinance shall be published one time in the "Lodi News-Sentinel", a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage.

Section 3. Upon the effective date of this ordinance, the City Clerk shall immediately prepare under seal a certified copy of the ordinance, giving the date of its passage, and transmit it to the Secretary of State. He shall also comply with the provisions of such statutes as may be applicable hereto to, effect the purposes hereof.


