

ORDINANCE NO. 871

AMENDING THE OFFICIAL DISTRICT MAP OF THE CITY OF LODI AND THEREBY REZONING CERTAIN PROPERTY LOCATED AT 510 MURRAY STREET TO BE IN THE R-MD, MEDIUM DENSITY MULTIPLE-FAMILY RESIDENTIAL DISTRICT

THE CITY COUNCIL OF THE CITY OF LODI DOES ORDAIN AS FOLLOWS:

Section 1. The official District Map of the City of Lodi adopted by Section 27-2 of the Code of the City of Lodi is hereby amended and the property hereinafter described rezoned and reclassified from its present classification as being in the R-4, Multiple-Family Residential Institutional District to be in the R-MD, Medium Density Multiple-Family Residential District, viz:

Beginning at the northwest corner of Lot 38, Lawrence Ranch Subdivision, Unit No. 1, as filed for record on April 10, 1953 in Volume 13, page 143, Book of Maps and Plats, San Joaquin County Records, thence easterly 224.25 feet along the south line of Murray Street, thence southerly 110 feet along a line parallel to the east line of said Lot 38 to the north line of the Lodi Grape Festival Grounds; thence westerly 224.25 feet along said north line to the southeast corner of said Lot 38; thence northerly 110 feet to the point of beginning.. . .

The alterations, changes and amendments of said official District Map of the City of Lodi herein set forth have been approved by the City Council of this City after public hearing held in conformance with the provisions of Chapter 27 of the Code of the City of Lodi and the laws of the State of California applicable hereto.

Section 2. All ordinances and parts of ordinances in conflict herewith are repealed insofar as conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel," a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.
