

ORDINANCE NO. 912

AMENDING THE OFFICIAL DISTRICT MAP OF THE CITY OF LODI AND THEREBY REZONING PARCELS LOCATED AT 1615 AND 1751 WEST LOCKEFORD STREET AND 410 AND 420 LOMA DRIVE TO BE IN THE R-GA GARDEN APARTMENT RESIDENTIAL DISTRICT.

The City Council of the City of Lodi does ordain as follows:

Section 1. The official District Map of the City of Lodi adopted by Section 27-2 of the Code of the City of Lodi is hereby amended and the property hereinafter described rezoned and reclassified from its present classification as being in the R-2, Single Family Residential District to be in the R-GA, Garden Apartment Residential District, viz:

Parcels located at 1615 and 1751 West Lockeford Street and 410 and 420 Lorna Drive, more particularly described as follows:


Beginning at a point at the northeast corner of West Lockeford Street and Lorna Drive; thence northerly along the east line of Lorna Drive 363.68 feet, more or less; thence easterly 176 feet, more or less; thence southerly 202.83 feet, more or less; thence easterly 236.8 feet, more or less; thence southerly 166.85 feet; thence westerly on the north line of West Lockeford Street 412.8 feet, more or less to the point of beginning of this description.


The alterations, changes and amendments of said official District Map of the City of Lodi herein set forth have been approved by the City Planning Commission and by the City Council of this City after public hearings held in conformance with the provisions of Chapter 27 of the Code of the City of Lodi and the laws of the State of California applicable hereto.

Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed insofar as such conflict may exist.

Section 3. This ordinance shall be published one time in the "Lodi News Sentinel," a daily newspaper of general circulation printed and published in the City of Lodi and shall be in force and take effect thirty days from and after its passage and approval.


