

ORDINANCE NO. 936

AN ORDINANCE AMENDING SECTION 14-59 OF THE CODE OF THE CITY OF LODI AND AMENDING SECTION 195 OF ORDINANCE NO. 493 OF THE CITY OF LODI ESTABLISHING PARKING TIME LIMITS ON CERTAIN STREETS.

The City Council of the City of Lodi does ordain as follows:

Section 1. Section 14-59 of the Code of the City of Lodi is hereby amended to read in full as follows:

SEC. 14-59. PARKING LIMITED AT CERTAIN TIMES
AND WHERE INDICATED BY SIGNS.

When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle on any of the streets designated by ordinance or resolution as streets upon which parking time is limited between the hours of 9:00 a. m. and 6:00 p. m. of any day except Sundays and holidays, for a length of time greater than that set out in any such ordinance or resolution and indicated on such signs.

Section 2. The first paragraph of Section 195 of Ordinance No. 493 is hereby amended to read in full as follows:

In accordance with Section 14-59 of the Code of the City of Lodi, parking is limited to the time hereinafter designated between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and holidays upon any of the following enumerated streets:

Section 3. All ordinances and parts of ordinances in conflict herewith are repealed insofar as such conflict may exist.

Section 4. This ordinance shall be published one time in the "Lodi News Sentinel," a daily newspaper of general circulation, printed and published in the City of Lodi, and shall be in force and take effect thirty days from and after its passage and approval.
