

RECOMMENDED ACTION: That the City Council set a public hearing for noon to 1 p.m. and continued to the regularly scheduled meeting of December 17, 1997, to consider unmet transit needs in Lodi. Both hearings will be held in the Carnegie Forum.

BACKGROUND INFORMATION: These public hearings are an annual requirement of the Transportation Development Act regulations. No major transit needs are expected to be identified. Requests will be made for longer evening and Sunday GrapeLine service, and weekend interregional service to Galt and Stockton. To date, there does not appear to be enough demand for any of these types of services.

After the hearing, it is expected that the San Joaquin Council of Governments will find that there are no unmet transit needs in Lodi.

FUNDING: Not applicable.




