
RECOMMENDED ACTION: Set public hearing for Wednesday, November 5, 1997 for State of California COPS (Citizen's option for public safety) program.

BACKGROUND INFORMATION: AB 3229, Section 1, Sub-paragraph 2, states, "The Legislature hereby finds and declares that there is a compelling need for additional resources to be applied at the local level for the purpose of insuring public safety."

For the second year in a row, Lodi Police Department will be awarded a state grant in the amount of \$126,737.00. The Legislation for this grant requires a public hearing to review the budget submitted by the Chief of Police. The money must be used for "front line" law enforcement and cannot supplant existing appropriations. No matching funding is required.

Lodi Police Chief Larry Hansen will submit a detailed budget and be available to answer any questions from the council and/or the public. **(A detailed budget will be presented at the November 5, 1997 Public Hearing.)**


