AGENDA TITLE: Set Public Hearing for May 16, 2001 for the Transit Division's FY 2001 Program of Projects

RECOMMENDED ACTION: That the City Council set a public hearing for May 16, 2001 for the Transit Division's FY 2001 Program of Projects.

BACKGROUND INFORMATION: The City of Lodi is required to hold a public hearing to allow the public an opportunity to comment on the City's transit projects funded by the Federal Transit Administration (FTA). In the past, very few, if any, comments have been given regarding the use of federal funds for transit projects. Staff expects the same this year. The program of projects will be published in the Lodi News Sentinel and a public hearing will be conducted on May 16, 2001. For FY 2000/01, the program of projects is as follows:




