
BACKGROUND INFORMATION: On July 3, 2002 the Lodi Police Department applied for a Grant from the Local Law Enforcement Block Grant Program Funds in the amount of \$85,989 which includes matching funds of \$8,599. The source of the matching funds will be taken from the 2002/2003 Lodi Police Department Budget. When the funds are received, they will be placed in a special revenue fund, pending dispersal. The police department intends to use the funds for software acquisition, and technology updates on equipment that is currently being used by Lodi Police Department.

FUNDING: Total Grant is \$85,989, including matching City Funds in the amount of \$8,599, **which** will come from current City budget.




