**AGENDA TITLE:** Public Hearing to Consider the Technical Equipment Purchase Proposal for Local Law Enforcement Block Grant Program

**DATE:** September 18, 2002

**PREPARED BY:** JERRY J. ADAMS, CHIEF OF POLICE

**RECOMMENDED ACTION:** That the City Council authorize the Lodi Police Department to purchase technical equipment that would enhance hardware and software that is being used by law enforcement personnel at the Lodi Police Department.

**BACKGROUND INFORMATION:** On July 3, 2002 the Lodi Police Department applied for and received a Grant from the Local Law Enforcement Block Grant Program Funds in the amount of \$85,989 which includes matching funds of \$8,599. The source of the matching funds will be taken from the 2002/2003 Lodi Police Department Budget. When the funds are received, they will be placed in a special revenue fund, pending dispersal.

On August 7, 2002 an Advisory Board convened and reviewed the proposal for the disbursement of those funds. The proposal indicated that the funds would be used for software acquisition, and technology updates on equipment that is currently being used by Lodi Police Department.




