RECOMMENDED ACTION: Set a public hearing for February 21, 2007, for the Transit Division's Federal Fiscal Year (FFY) 2007 Program of Projects.

BACKGROUND INFORMATION: The City of Lodi is required to hold a public hearing to allow the public an opportunity to comment on the City's transit projects funded by the Federal Transit Administration (FTA). In the past, very few, if any, comments have been given regarding the use of federal funds for transit projects. Staff expects the same this year. The City of Galt will adopt their own Program of Projects for their portion of the funding. The Program of Projects will be published in the *Lodi News Sentinel* and a public hearing will be conducted February 21, 2007. For FFY 2007, the Program of Projects for the City of Lodi is as follows:

Operations for City of Lodi for 2006/07	\$761,613
Facility Upgrades Project	\$152,000
Bus Shelters and Amenities Project	\$ 80,000
Total	\$993,613

FISCAL IMPACT: This will allow the City of Lodi to claim and receive FTA funding for the Federal Fiscal Year 2007. These funds will pay for on-going operations, as well as needed capital improvements.

FUNDING AVAILABLE: None required.
