



RE: Use Permit Parking Lot - 1001 York Street


At its meeting of Monday, December 14, 1981, the Lodi City Planning Commission, by a 3 to 3 vote, with Commissioner Kirst absent, denied your request for a Use Permit to use the single-family parcel at 1001 York Street as an off-street parking lot for the expansion of Fairmont Rehabilitation Hospital at 950 South Fairmont Avenue.

Section 27-15 of the Lodi Municipal Code (i.e. Zoning Ordinance) provides the following:

"Appeal. Any applicant or person claiming to be directly and adversely affected by any action of the Planning Commission may, within five days after the action (i.e. working days), file a written appeal with the City Clerk for transmittal to the City Council."

If you wish to appeal, your correspondence should be directed to Alice M. Reimche, City Clerk and must be received by her before 5:00 p.m., Monday, December 21, 1981.
