Notice thereof having been published in accordance with law and affidavit of publication being on file in the office of the City Clerk, Mayor McCarty called for the Public Hearing to consider the following matters:

- a) Consider the City Planning Commission's recommendation for approval of the request of Garth Johnson to amend the Permitted Use List in the C-S, Commercial Shopping District to permit Electronic Game Centers after first acquiring a Use Permit from the Planning Commission
- b) Consideration of the certification of the Negative Declaration for a Coin-operated Arcade Text Amendment to the Commercial Shopping (C-S) Zone Classification.

The matter was introduced by Community Development Director Schroeder who presented diagrams for Council's perusal. Mr. Schroeder cited various shopping centers in the community that would be affected by such a change.
