

RECOMMENDED ACTION: That the City Council adopt a resolution of intention to abandon an easement, refer it to the Planning Commission, and set the matter for Public Hearing on September 3, 1986.

BACKGROUND INFORMATION: The easement abandonment has been requested by the owner in order to clear the lot of an easement which is not used. Additional easements will be granted to cover any requirements of the various utilities.

Funds have been provided for the necessary advertising, and P.G. & E., Pacific Bell, King Videocable Co., and City utilities have been notified of the proposed abandonment and their approval will be secured prior to the final action.


The proposed abandonment is shown on the attached sketch.






