SUBJECT: Setting of Public Hearings for Required Installation of Sidewalks

RECOMMENDED ACTION: That the City Council set October 2, 1985 at 7:30 p.m. as the time to hear and pass upon objections or protests raised by any property owner or other interested persons regarding the "Notice to Construct Sidewalks" in front of their property.

BACKGROUND INFORMATION: Notices to Construct will be sent to the property owners at 302 N. California Street and 525 W. Lockeford Street. These two properties are the only ones without sidewalk in the area of the California Street improvement project. The Notices require that construction of the sidewalk fronting their property commence within 60 days. The State of California Streets and Highway Code requires that the legislative body hear and pass upon objections at a hearing which shall be set no sooner than ten (10) days after giving notice.
