

RESOLUTION NO. 95-152

A RESOLUTION OF THE LODI CITY COUNCIL
AWARDING THE BID FOR ONE PHOTOCOPIER FOR
HUMAN RESOURCES DEPARTMENT

WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council sealed bids were received and publicly opened on December 6, 1995 at 11:00 a.m. for the bid for one photocopier for the Human Resources Department, described in the specifications therefore approved by the City Council on November 15, 1995; and

WHEREAS, said bids have been compared, checked, and tabulated and a report thereof filed with the City Manager as shown as follows:

BE IT FURTHER RESOLVED that a transfer of \$1,378.31 from the Contingency Fund is hereby authorized to cover the unfunded portion of this purchase.


