

RESOLUTION NO. 99-36

A RESOLUTION OF THE LODI CITY COUNCIL APPROVING
PARKING RESTRICTIONS, AND THEREBY AMENDING
TRAFFIC RESOLUTION NO. 97-148

BE IT RESOLVED, that the City Council of the City of Lodi does hereby approve parking restrictions, as shown on Exhibit A attached hereto, at the following locations:

- 1.) **Cherokee Lane** – prohibit the parking of vehicles six (6') feet or more in height on the east side of Cherokee Lane from Almond Drive to 100 feet north of Almond Drive; and
- 2.) **Cherokee Lane** – restrict commercial vehicle parking from 7:30 a.m. to 9:00 p.m., everyday on the east side of Cherokee Lane from 180 feet north of Almond Drive to 653 feet north of Almond Drive in front of the property addressed 1700 and 1740 South Cherokee Lane.
- 3.) **Beckman Road** – restrict commercial vehicle parking from 7:00 a.m. to 8:00 p.m., everyday on the east side of Beckman Road from Vine Street to 350 feet north of Vine Street in front of the property addressed 880 South Beckman Road.

BE IT FURTHER RESOLVED, by the City Council of the City of Lodi that the City of Lodi Traffic Resolution No. 97-148, Section 3D & 3C (10 & 11) "Street Parking Restrictions" is hereby amended and added to as follows:

Section 3D:

- 1.) **Cherokee Lane** – prohibit the parking of vehicles six (6') feet or more in height on the east side of Cherokee Lane from Almond Drive to 100 feet north of Almond Drive; and

Section 3C (10):

- 2.) **Cherokee Lane** – restrict commercial vehicle parking from 7:30 a.m. to 9:00 p.m., everyday on the east side of Cherokee Lane from 180 feet north of Almond Drive to 653 feet north of Almond Drive in front of the property addressed 1700 and 1740 South Cherokee Lane.

Section 3C (11):

- 3.) **Beckman Road** – restrict commercial vehicle parking from 7:00 a.m. to 8:00 p.m., everyday on the east side of Beckman Road from Vine Street to 350 feet north of Vine Street in front of the property addressed 880 South Beckman Road.


